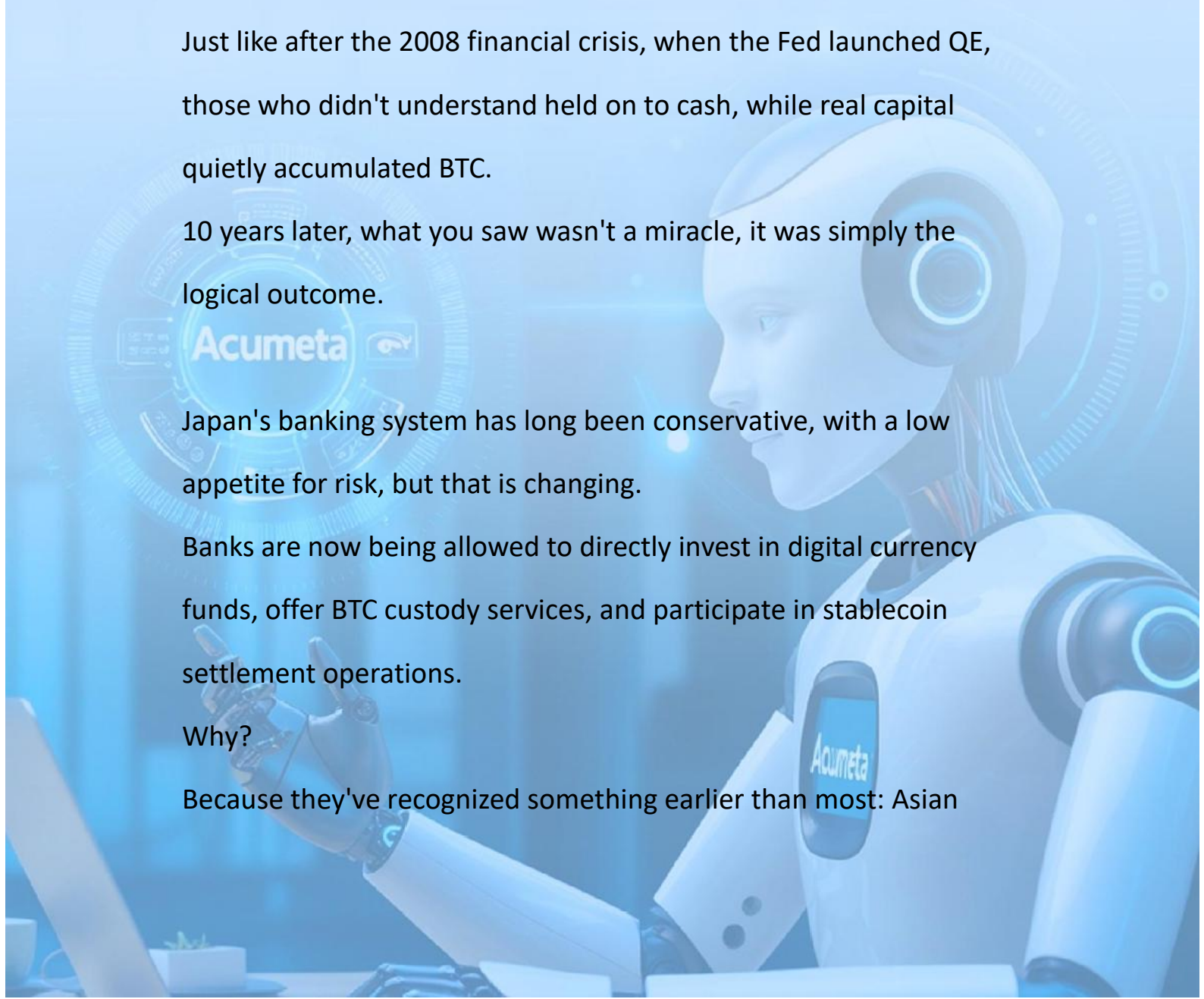

Because they've recognized something earlier than most: Asian

capital is no longer fixated solely on gold or real estate.

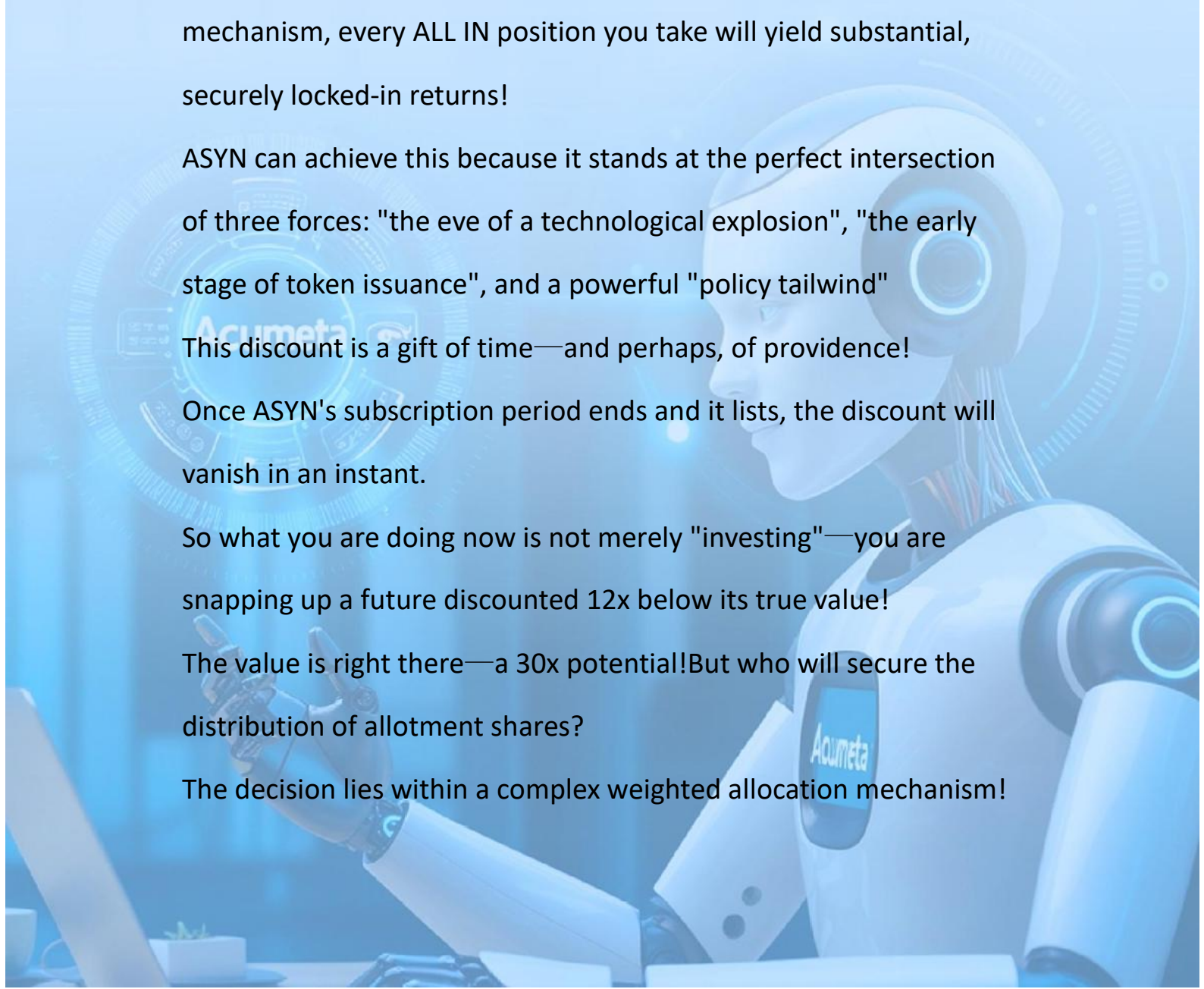

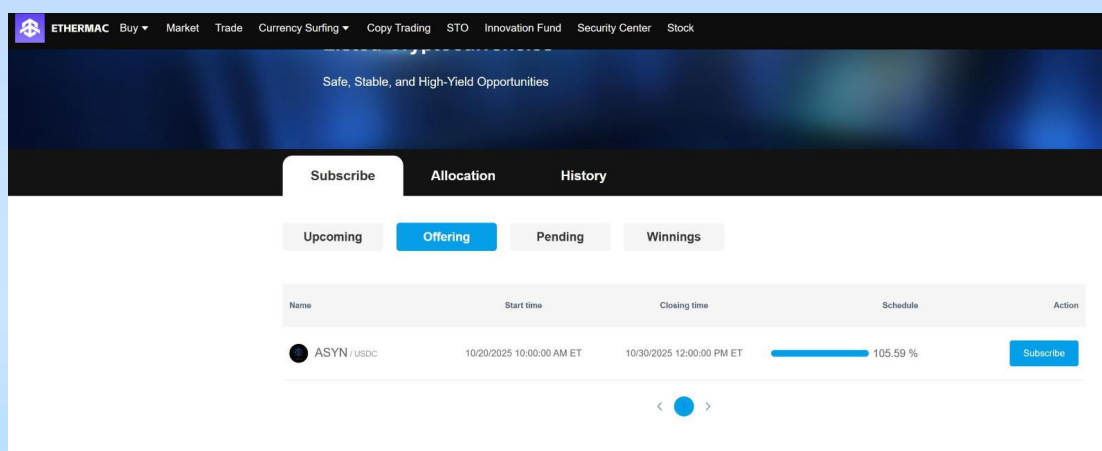
